Motion 101/2018 – Corresponding Member for Executive Meeting – June 5, 2018

Mark Satterly.”

Linda Paul agreed to write the letter to the Rev. Mark Satterly outlining the motions that were passed.

Presbytery Executive agreed to meet at 5:30 pm at St. Andrew’s River Heights United Church on Tuesday, June 12, just prior to the meeting of Presbytery, to approve the names of those involved in these reviews.
